**EXECUTIVE SUMMARY:**

**Introduction and background**

Brewarrina Shire Council announced the Brewarrina Shire Heritage Fund Program in May and two applications were received from the community.

Heritage Advisor Laila Haglund has analysed and examined the applications and prepared a recommendation in the report attached.

**FINANCIAL IMPLICATIONS:**

Allocation of \$16,938.00 for the Heritage Fund of which Council has allocated in the 2010/11 Budget (\$5,646 from the Heritage Branch of the Department of Planning (1/3 for year 10) and \$11,292 from Brewarrina Shire Council).
